

TOPIC

IMMIGRATION AND ITS IMPACTS ON EU LABOUR MARKETS

One year on from Russia's invasion of the Ukraine, it has become clear that the effects of the war, both direct and indirect, will last for many years and permeate throughout the whole of Europe. Both the migration and employment crises pose major challenges for the EU. In our Lunch Debate, we will discuss how immigration is impacting EU labour markets.

Many countries in the EU are facing chronic labour shortages which increasingly threaten the smooth functioning of labour markets. At the same time, EU Member States are experiencing a massive influx of workforce through immigration.

How do employment, unemployment, wages or job content respond to immigration? Are there winners – and losers? Do migrants "take" jobs from domestic workers, or do they create new jobs? May immigration even be a remedy to labour market shortages? And what is the European answer to the employment challenge?

Based on a ZEW policy brief on migration policies to address labour shortages, these and other questions will be at the centre of this ZEW Lunch Debate.

Katrin Sommerfeld is head of ZEW's Junior Research Group "Integration of Migrants and Attitudes towards the Welfare State (IMES)" in ZEW's Research Unit "Labour Markets and Social Insurance". Her research focuses on migration issues such as the recent influx of refugees into Germany and Europe.



Barbara Surdykowska is a legal advisor at the Expert Office of the National Commission NSZZ Solidarność trade union. She works as an expert at the Institute of Public Affairs and CASE (Center for Social and Economic Analysis). Among other things, she deals with workers' social security, collective bargaining and the issue of migrants on the Polish labour market.



Nicolas Ziebarth is head of ZEW's Research Unit "Labour Markets and Social Insurance" and a professor of economics at the University of Mannheim. His research studies the interaction of (social) insurance systems with labour markets and population health.
